Opening

- 161 The meeting opened at 7:30 pm
- No members of the public were present.
- 163 Apologies for absence were noted.

Appointment of Coopted Member

164 Mrs P K Payne was appointed as a Coopted Member.

Declarations of Personal and Prejudicial Interests

165 None was declared

Minutes of the Meeting of Council 5 Sep 11

The minutes were approved as a true record.

Matters Arising

- Minute 120. The Chairman had reported preliminary markings for the proposed yellow lines had been painted on the roads at Bremridge Close, Wasperton Lane and Sandy Way but there had been no further progress. Cllr Caborn would be asked to expedite the work.
- Minute 121. Despite the footpath beyond Seven Elms having been unblocked, the Chairman drew attention to the fact that other footpaths around Wasperton had been ploughed over with no apparent attempt at restitution. The matter had been reported to WCC Rights of Way officers.

[Cllrs McVeigh and Rhead joined the meeting]

- Minute 124. Responding to Cllr Mrs Gordon's observations, the Chairman said that he had cleared the rain gutters on the Sherbourne bus shelter, cleared overhanging vegetation and cut back the adjacent pavement. There was still litter in the ditch behind the shelter which, he thought, would probably be best tackled by self-help given WCC reluctance to date.
- 170 <u>Minute 148.</u> There was no progress to report on the Queen's Diamond Jubilee beacons and members of the WP resolved to bring a report to the next JPC meeting.

- Minute 150. At the last meeting Cllr Caborn had said that within the next two weeks a meeting of WCC personnel with interested parties from the JPC would be arranged to discuss the traffic flow and speed limits in the area of the northern Barford junction from the bypass and the roads in Sherbourne. That had not happened and the Chairman undertook to pursue the matter.
- Minute 151.1. Notices had been posted in Wasperton giving information about the planned introduction of a 20mph speed limit.

176 The JPC took note of the Management Accounts at Annex A to these minutes.

Acquisition of Riverside Land

- 177 The JPC approved the execution of the two licences for the Riverside Land at a total cost of £400.
- 178 Cllr Mrs Barlow informed the JPC that with the verbal consent of WCC work had started on site clearance for the trees.

WCC Grant to Sherbourne Village

Notwithstanding an impression to the contrary, WCC had stated that in considering an application for a grant for refurbishing the hall's interior it would wish to deal directly with the body with legal responsibility for the hall (which is the Management Committee in its capacity as Leaseholder and Charity Trustee) and not some unrelated third party (the JPC for example).

New National Planning Policy Framework

The JPC considered its response to an invitation from NALC to respond to a policy consultation on the proposed "National Planning Policy Framework".

- Cllr Rhead explained that it was difficult to consider this in isolation because clarification was required on the interaction of the Localism Bill with the Framework, neither of which was yet law. In his capacity as a member of WDC he and Cllr Caborn (WCC) would soon attend a symposium at which light would be shed on the matter.
- Whatever the detailed outcome of the emerging legislation it was clear that key to progress in this area was the formulation of a new Local Plan for Warwick District, and this was currently in progress by WDC's Local Plan Development Working Party. Furthermore it would be essential to have current, comprehensive Parish and Neighbourhood Plans in place.
- Cllr Wright persuaded the meeting that however uncertain the future, the JPC should respond to the consultation, but because of time constraints (closing date for submission 17 Oct 11) an abbreviated procedure needed to be adopted. The JPC therefore approved the following: Cllr Wright to draft a response and pass it to Cllrs Clay and McVeigh for approval. The agreed document to be sent by Cllr Wright to:
 - NALC.
 - The Clerk for distribution to the whole JPC.
- The printed agenda item containing the NALC consultation document had included a preamble from WALC office quoting reports in the media on the implications of the Framework. The accuracy of some of those WALC statements was challenged and a discussion ensued whether to include the preamble details in the minutes. On the basis that these reports did not form part of the consultation document the JPC voted not to do so.

Review of Parliamentary Constituencies

The JPC took note. The JPC parishes would probably remain part of the new enlarged Warwick and Learnington constituency.

Affordable Housing

The JPC received a report from the Affordable Housing Working Party and approved in principle the scheme as presented whilst acknowledging the current lack of availability of finding for such a scheme.

WCC Waste Core Strategy

There being no enthusiasm for forming a working party to respond to "Waste Core Strategies - Preferred Options and Policies" Cllr Mrs Gordon volunteered to study the document and to respond as an individual, bringing back to the JPC any matters deserving of its attention. The offer was gratefully accepted.

Any Other Business

- 188 Planning.
- 188.1 The WDC Proposed Development Review Forum will meet on 31 Oct 11 to hear the case for development at Barford House. The Chairman encouraged members' attendance.
- 188.2 Cllr Morris said that the Barford Residents' Association (BRA) would consider the subject before that meeting which he would attend. The Chairman reminded him that at the meeting he had the right to speak as a member of the JPC but not as a BRA representative.
- 189 <u>Wasperton Notice Board.</u> Cllr Thurley asked what action was necessary to procure a new notice board for Wasperton Village Hall. The Clerk said that if permission were obtained from the hall's owner to fix a new one to the wall, he would make it.
- 190 <u>"Free Trees for Your Community"</u> Cllr Mrs Barlow drew attention to the offer of free trees (which had been distributed to JPC members).

- 191 <u>Wasperton Street Lighting.</u> Cllr Metcalf reported that a number of minor accidents, attributable to inadequate street lighting, had occurred in Wasperton. He had brought the matter to WDC's attention. The likely cost of a new lamp standard was c£3k.
- 192 <u>Defibrillator.</u> Cllr Rhead informed the meeting:
 - The new defibrillator will be delivered next week.
 - It is to be installed at the Barford Village Shop.
 - It will be blessed by Rev Jessett at the switching on of the Christmas lights.
- 193 <u>Road Signs.</u> Cllr Mrs Payne wondered if there was a way of removing signs to the Nursery now that it had closed to prevent people aimlessly searching for it. The Chairman promised to investigate.
- 194 <u>Barford Post Office.</u> The Chairman advised members that the Post Office is now open Mon-Fri 1500-1715h.

195 There being no other business the meeting closed at 9:00 pm.
