136 The JPC nominated the Rev David Jessett and Gerard Veness as Trustees to the Barford Relief In Need Charity to serve for a four-year term from 16 Nov 14

Barford War Memorial

- 137 An entry in the War Graves Commission's Register reads: "CONLON, A.B. HARRY, D/JX. 146785, R.N. *H.M.S.Diamond.* 28th April 1941. Age 21. Son of Ethel Conlon of Barford, Warwickshire." His name does not appear on the Barford War Memorial.
- The Rev David Jessett has received a request that this omission be rectified. He is sympathetic to it. The Clerk's research suggests that always provided the local vicar and the owner of the memorial (in this case the JPC) agree then the name may be added.
- Members agreed in principle that his name should be added; this to be confirmed at the November meeting when the costs will be known.

Barford Leisure Improvement Scheme

- 140 The Chairman reported:
- 140.1 The scheme continues to progress well and it was hoped to bring a final recommendation for the Children's Play area to the next JPC. Funding was also going well although it was getting very complicated matching various different providers with varying criteria. Received so far was £30k from Barford Community Charity and £3k from Warwick Rural West Community Forum. It is hoped that WDC would soon confirm an application for £30k and that Barford School Trust would also provide significant support. The Taylor-Wimpey (old Sherbourne Nursery) site had a s.106 provision of c.£87k available at 50% completion and there was a request for £34k in the event that the Sharba appeal was successful, although the latter was not guaranteed for the scheme. There were also many other funding applications in train with sport specific organizations although these were at an earlier stage at present. As many of the funds were very specific in relation to exactly what was funded we needed to ensure some flexibility and the chairman indicated that the JPC should consider making some further budget provision in the coming financial year to cover any funding failures or elements that did not come under the remit of external funding organizations.
- 140.2 Drainage on and near the site had been identified as an issue and the outflow entered the Barford House/Sharba site where the ditches were largely blocked. Involvement of WDC/WCC Flood Managers had clarified various matters and there may be a requirement to take "enforcement action" on that site to re-establish effective watercourses once the JPC area had been put in order. Meanwhile, as part of the overall scheme, the JPC would need to clear the Playing Field margin

ditches and undertake some remedial works on the discharge culverts adjacent to the track/public footpath.

140.3 It was intended to stage some events to further raise resident awareness of the scheme, to raise some local funds and to achieve further resident "buy-in".

WDC New Local Plan

The Chairman stated there was little further progress to report. A further round of consultation in mid-late October and progressing to Inspection early in 2015.

Gypsy & Traveller Sites

- A question arose about the need for consultation on the final sites selected by WDC with the concern that if for any reason they were eventually rejected then the hunt would be on for replacements, possibly in the Barford area.
- 143 The Chairman undertook to try to clarify the matter and, true to his word, circulated to the JPC the following extract from the WDC website immediately after the meeting:

One of the proposals is to accommodate a Gypsy and Traveller site on land off Stratford Road Warwick. The Executive at its meeting on 30th July 2014 has already agreed to undertake a consultation on the possible inclusion within the Local Plan, of this land for employment purposes. In discussing this possibility with the other 2 principal landowners, it became clear that the site appraisal for both employment and for a gypsy and traveller site needs to refer to a wider area of land than had been agreed by the Executive. Consequently two things arise: that the consultation on the release of land for employment purposes needs to extend to the wider area of land shown in Appendix A of Appendix 2 (which is a decision of the Executive); and the public consultation on the employment land and the Draft Development Plan for Gypsy and Traveller sites need to be run concurrently in order to avoid confusing the public. At present it is not possible to be absolutely certain when the 6 week consultation will take place as it is dependent on a number of unknown factors regarding the assessment, however it is hoped that the consultation could commence during the last week of August."[Now expected to start mid-late October prior to going to Inspector]

Barford Neighbourhood Development Plan

- 144 Cllr Mrs Barlow distributed copies of the draft version of the plan which was out for consultation. She encouraged everyone to submit their views, supportive as well as critical.
- The JPC was very appreciative of the time and effort contributed by members of the BNDP Committee and greatly impressed by their skill and knowledge. Cllr Merrygold (who attended meetings of the committee in an observer capacity for Sherbourne and Wasperton) endorsed those sentiments from his own experience.
- 146 It was agreed that once the BNDP had been completed the Clerk would write a letter of thanks to the Working Party.

Any Other Business

- 147 Cllr Mrs Gordon reported that the new lamp standards in Sherbourne had been painted. She also described how a campaign to prevent over-weight vehicles passing through the village was being conducted by contacting the operators directly.
- 148 Cllr Caborn (WCC) had left a message for the JPC advising that the Minerals Plan was being updated and that sites in and around its area would once again be subject to consideration.
- The Chairman advised that at the recent Community Forum he had stressed the problem of dangerous traffic conditions outside Barford School and the Police had committed to some high-profile advisory patrols at peak times. He also reported on a plan, proposed by Barford Village Shop, to position a decorative sign-post in Barford in the vicinity of the mini-roundabout pointing to the village shop, Memorial Hall, church and school. BVS was working with Mr Mayes at WDC to achieve installation in the most advantageous and convenient manner.

Closure

150 There being no other business the meeting closed at 8:10pm.
