Taylor Wimpey Development Barford

238 The Chairman gave an update:

- Planning preconditions have been signed off.
- Some preliminary work (hedgerow removal) had been completed.
- The idea of keeping residents informed by using notice board information had been vetoed by Taylor Wimpey which will rely instead on delivering letters to residents.
- Over-sized trucks would access the site after prior notice had been given.
- 239 A site meeting with residents has been promised when work starts. It has been agreed that Dr Chris Morrow will attend future meetings between JPC, WDC and Taylor Wimpey

Barford Leisure Improvement Scheme

240 Cllr Murphy reported:

- The uncertainty about a final bill from Severn Trent remains unresolved.
- Barford Sports Club management is reviewing future maintenance requirements.
- The recent cold-spell caused frost damage to plumbing on King George's Field.

Any Other Business

- 241 Cllr Hawkesford relayed a request from a resident for more pedestrian crossings in Barford. Cllr Mrs Hunt endorsed the need, observing that traffic through the village, notwithstanding the bypass, continued to increase. It was agreed to consider this in more detail at the next meeting.
- 242 The Chairman, responding to the news of a resident's serious fall on the ice in Keytes Lane due, in no small part, to the poor state of repair of the pavements said he would visit the site, take photographs and draw WCC's attention to the need for remedial action.
