### **Any Other Business**

- 147 <u>Cllr Caborn.</u> Work on modification to the northern entrance to the Barford Bypass to improve safety is scheduled for 23-30 Mar 20.
- 148 <u>Cllr Sheard.</u> Gave a report from the Sand and Gravel Action Group which was subsequently sent to all JPC members. A plea for assistance from the JPC will be considered at the next meeting.
- 149 <u>Cllr Rhead.</u> Spoke about the Climate Emergency activity in WDC and the intention to increase the Council Tax by £1.00 for Band D dwellings (and pro rata for the other bands) to raise a fund exclusively for this enterprise.
- 150 <u>Cllr Mrs Hunt.</u> Raised the matter of the use of Facebook for discussion of JPC activities. This will be considered at the next meeting.
- 151 <u>Cllr Murphy.</u> Gave details of a new agency, NSL, responsible for responding to complaints about illegal parking, and reported on its swift and effective action on an occasion when numerous heavy, contractor's vehicles were parked on yellow lines in Bremridge Close; all were "ticketed".
