# King George's Field

170 Cllr Murphy reported:

- Vandalism damage has largely been repaired.
- Replacement of broken window in hand.
- Ramp to be restored.
- Tennis court to have the moss removed. (It is a necessity that this is repeated quarterly for

- safety reasons).
- Replacement nets to be procured.

## **Coronation of King Charles III**

- 171 The JPC agreed that the suggestion from the WI of a "Street Party" on the Village Green was a good idea. Cllr Murphy confirmed that at no charge both the Barford Memorial Hall would be available and the use the tables.
- 172 The JPC agreed to plant a tree to commemorate the Coronation, preferably a British oak, in a suitable spot in KGF. It was agreed that the tree should be planted by school children rather than a local dignitary.
- 173 To organize this a working group was formed comprising:
  - Cllr Clav
  - Cllr Gadsden
  - Cllr Mrs Haynes
  - Cllr Hawkesford
  - Cllr Murphy
  - Cllr Sheard

#### 174 Its brief:

- Procure a substantial tree (3-4m high) at a price between £200-£400.
- Agree a suitable location.
- Organize a suitably worded plaque.
- Plan the logistics of planting and how it works with children.
- 175 Cllr Gadsden is to liaise with Barford School both to plan the children's tree-planting and to learn what other activities the school may have in mind.

# Sand & Gravel Action Group (SAGAG)

- 177 The JPC has a mission to prevent the opening of a gravel pit adjacent to Barford through the medium of SAGAG but being uncertain about its legal powers to provide financial assistance through Section 137, appealed to WALC for expert guidance. Which was that a parish council should not put at risk public money by supporting an aim which may not be achieved. With the utmost reluctance therefore the JPC declined to make the grant.
- The JPC thought however that if it were, in its own right, to undertake part of the work for which the grant was requested then the problem would be solved. It provisionally earmarked £5k net to commission an expert study on the threat to public health posed by dust and particulates- a real danger- and present this as evidence at an appeal hearing but would await WALC's response before committing to the expenditure.

[Afternote: Response from WALC "This is not something which the Council should embark upon. Such a survey would be expensive and time consuming and it would normally form part of the environmental information given by the applicant for the planning application. The council

should discuss this with the Principal authority before undertaking this. Our advice is not to do this."]
