## King George's Field

189 Cllr Murphy reported:

- The windows have been reglazed.
- The grills have arrived for fitting.
- Cllr Clay is sourcing a 'push' tap with a horizontal action rather than vertical to relieve stress on the external panel

#### Coronation of King Charles III

190 Cllr Gadsden gave a summary of the planned celebratory event:

- Event starts on 3<sup>rd</sup> May at 2:30pm
- The Lord Lieutenant will officiate
- One child from each year group to form the tree planting group
- Tea and coffee to be provided by the school
- The area to be decked with bunting
- The children will perform dancing and singing
- A drone has been arranged for photographs
- A PA system will be installed
- The planting ceremony will start at 3:30pm
- The plan is to contact old Barfordians who were present at the 1953 Coronation tree planting
- Contact Tanya Aspinwall for local press coverage
- Tree and fencing cost £395
- The plaque would be purchased now wording equivalent to 1953 but with St Peter's added to school name, and it to be mounted on a post inside the protective fencing

#### South Warwickshire Local Plan (SWLP)

- 191 The purpose of this agenda item had been misinterpreted, with Barford and Wasperton believing a preliminary meeting of the SWLP Working Party had been intended before decisions were made but Sherbourne's interpretation being to make an assessment forthwith for presentation at the JPC meeting.
- 192 Discussion was held over until after the scheduled meeting of the SWLP WP on 15 Mar 23 with a further meeting planned for 20 Mar 23.

#### Sand & Gravel Action Group

- 193 The JPC had met to establish the measure of support which its members would give to commissioning an expert report on the threat to public health posed by dust and particulates, paying for it using Section 137 monies and risking the outcome. On this no consensus was reached.
- 194 Some cast doubt on the binding nature of WALC's advice and suggested that an appeal directly to NALC might be more profitable.

[Afternote: The Clerk's message to NALC was politely rebuffed. Its rules of procedure require such a request to be made to it by WALC. WALC was informed and passed a request for legal advice back to NALC]

## **Any Other Business**

195 Cllr J Matecki reported: "I have secured funding from my delegated budget to introduce a 20mph speed limit in parts of Barford. Bridge Street and Church Street/High Street have initially been identified as possible roads for a reduced limit. I will now be working with the Highways team to progress the scheme."
