Wilding and Wildflowers

- It was agreed to set up a Barford working party to facilitate cooperation with Warwickshire Wildlife Trust (WWT). The project includes new hedging, hedge augmentation and wildflower sowing at various locations across the parish. A draft contract had been received and would be considered in due course.

With a representative of Bar Zero invited to attend.

Cllrs Billingham, Jackson, Merrygold and Mrs Wallis expressed interest in similar activity in Sherbourne and Wasperton and asked to be kept appraised if WWT could facilitate wilding activities in their parishes, understanding that currently there were no areas under JPC control in those parishes.

WWT's involvement is supported by grants from Severn Trent and hence costs to the JPC will be kept to a minimum and charged to Open Spaces Maintenance. Future maintenance would be at JPC expense but would not be over-burdensome.

Barford Neighbourhood Development Plan (BNDP)

- Seemingly BNDP has lost some of its original impact with later regulations by other bodies ignoring or over-riding parts of its provisions. The JPC considered a quinquennial review was necessary to reconsider its content.

S106 Works

- Good progress had been achieved. Outstanding projects included KGF signage, Barford Village Green wall, extension of Outdoor Gym area, and BYCC outdoor elements. Cllr Sheard raised the matter of the BMH/BVS car park wall as a further item for s106 funding and was requested to bring further detail and quotations to a future meeting for consideration.
- 37 The Chairman sensed that the enthusiasm for the Outdoor Gym had waned and that the project could be delayed for future re-evaluation.

BYCC

The project is fully funded. The promissory note for £20k from the JPC, funded from its reserves, can be redeemed once contracts have been issued. That for <£40k funded from the WDC Funding Offer for Outdoor Spaces requires disciplined analysis if the

possibility of it being of necessity funded from JPC resources instead is to be avoided.
