Sherbourne Park Estate Applicant: JPC Decision: Objection for these reasons

The JPC does not believe the car parking is adequate for the planned change of use of the building. The Applications shows four parking spaces beside the building, one of which is a garage. This garage is relatively old and too narrow to house a modern vehicle, plus it is equipped with hinged wooden doors, the opening and closing of which will reduce the available parking space. Therefore the site only has three practical parking spaces, but the plans for the office space show it will be equipped workstations for ten people. Even if the two workstations at the rear of the office are planned to be used as a meeting or breakout space, then the offices are planned to accommodate eight people.

Three parking places are not sufficient for an office of eight to ten people which means the extra vehicles will end being parked up along Church Road, which is already narrow, with residents' cars parked for large parts of the working day. In addition to this, while the two properties opposite the Village Hall have off street parking, they have gated drives whose entry and egress requires a clear sweep of the road. Church Road does not have to capacity to absorb the excess parking that the offices will generate.
