- 181 The minutes were accepted as a true record.
- 182 Matters Arising:
- 182.1 Minute 151. Cllr Byerley reported that although a positive response had been received from the landowner (the Church) for the installation of a water supply, the Scouts and Guides Group were proving less cooperative. He sought and obtained authority for him and Cllr Clay to negotiate to an agreed conclusion with the other parties and contractors.
- 182.2 Minute 168. Cllr Worrall was to attend the meeting of Warwick District Panel West on 11th October.
- 182.3 Minute 173. Once again complaints were made that the bus shelters in Sherbourne and Wasperton were not being cleaned thoroughly. It transpired that the complaint was about the vegetation on the outside of the shelters and dealing with this was not in the contract let to S&D Window Cleaners. It was agreed that another contract should be let to a different supplier for this service and the Chairman undertook to identify a suitable candidate.

A46/M40 Junction 15 (Longbridge) Bypass

- 188 All deliberations on this matter were now focused upon the public inquiry which had been announced. The JPC's position was:
- That its objection to the project was extant.

Oldham's Transport Site Development

- 190 The sponsors of these names were invited to furnish a written justification for the choice to the Clerk who would communicate the JPC's preference to WCC

Barford Village Shop Action Group

- 191 Members received a progress report from the Shop Action Group.
- 192 One of the possible sites for the shop would be in an extension of the Barford Memorial Hall onto the Village Green, and agreement in principle to this by the JPC was sought and granted.

- 193 Street Lighting. A tree is obscuring a street light in Sandy Way
- 194 Sandbags 2007. WDC requires information on the availability of sandbags for flood defences. Cllr Mrs Gordon undertook to provide the Clerk with details for Sherbourne.
