Henry decides to write down a list of all of the localizable codes from the set of localizable sentences about seeking information about relatives and friends after a disaster in numerical order of the encoding that he has devised.

'Yes, some moving around might be needed later but this will make a good start.' thinks Henry.

'Also, it will show up those localizable sentences that do not yet have a code number and also any gaps that need filling - such as the need to have localizable sentences about the gender of the enquirer.'

Henry starts to produce a list using the codes that he has already decided on previously yet has not written out in full thus far.

'Right' thinks Henry 'that is seventy of the eighty that have already been set out, together with three suggestions for additional sentences, so now I need to write into this document the ten other sentences from those that have already been set out, and check that it is ten and that I have not miscounted.'

Henry looks through the source document, checks what is not yet encoded in the present exercise and copies the ten sentences.

Henry writes down the codes in numerical order and adds them into the list.

Henry decides to add some spacing so as to start the list of codes on a new page.

Henry looks through the list of codes and notices that while preparing the list he had added four hyphens at the start of some otherwise empty lines so as to help in finding more easily where to add items. In each such place Henry removes the hyphens, leaving a blank line.

Henry also notices that after three of the sentences in the list - those he is suggesting for addition to the list - he had put four spaces and ADD? so as to note where they are. Henry decides to delete the three occurrences of the four spaces and ADD? from the list, leaving the new sentences as part of the list.
