Privacy Policy of the South Wales Gliding Club

This statement explains the South Wales Gliding Club's policy about the personal information you give us.

1. **Statement of intent**
We may ask you to submit personal information about yourself such as your name and email address to enable us to supply you with certain services. Whenever you provide personal information, we will treat that information in accordance with this policy. The South Wales Gliding Club will act in accordance with current legislation and aim to meet current Internet best practice. Any information you provide will only be used within the South Wales Gliding Club. It will never be supplied to third parties without first obtaining your consent, unless we are obliged by law to disclose information.
2. **Submitting personal information**
When you supply any personal information to the South Wales Gliding Club we have legal obligations towards you in the way we deal with that data. We must collect the information fairly; we must let you know how we will use it; and we must tell you in advance if we decide to pass the information on to anyone else. We will ensure that all personal information supplied is held securely, in accordance with the Data Protection Act 1998.
3. **Access to your personal information**
